The use of digital approaches in engaging with young people on issues of identity, discrimination, group hatred, violence and the role of social media has been a central tool.</p> <p>This workshop presents the “Call of Prev” project, which links game-based learning with cross-phenomenon prevention work (Right-wing extremism and Islamic extremism). This workshop presents the different psycho-educational tools that can help first-line practitioners working with youth in this task developed during the ARMOUR project. 3	City-Based Approaches I: Strengthening Coordinated Response & Prevention – Lessons from City-Based Multi-Stakeholder Approaches in Europe	<p>Cities are at the forefront of experiencing the challenges of extremism and hate. Across Europe there have been several significant efforts to pioneer working within cities, developing ‘safe cities’ and city-based approaches to challenging radicalisation and hate. This session will focus on lessons from four major platforms on how cities can engage to address extremism, and the importance of collaboration across sectors – including local governments, law enforcement agencies, civil society, and more. 7	<p>Getting Better at Getting Better: Evaluation, Learning Lessons and Improving Policy and Practice in the EU</p>	<p>From 2001 to today a vast amount of work has taken place across Europe targeting extremism, radicalisation and hate. From the European Commission to national governments, hundreds of millions of Euros have been spent across the EU. The breadth of projects implemented – their strategies and approaches, how they’ve been done, measures that have worked and measures that have failed – is vast.</p> <p>This session addresses both the need to improve practical evaluation and learning in the CVE/PVE field and how we can do it. Bringing together top experts in evaluation from RAN and projects IMPACT Europe and INDEED, the session will address how to do monitoring and evaluation of PVE/CVE projects; creating sectoral, city and national evaluation frameworks; innovations in sharing experiences and how to utilise the results of evaluation and learning to improve policy and practice. 8	<p>City-Based Approaches II: Assessing, Preventing and Mitigating Polarisation</p> <p>Simultaneous interpretation </p>	<p>In the framework of this workshop municipalities and experts will present innovative methods and tools to assess and diagnose polarisation and provide examples of tailor-made activities to mitigate or prevent polarisation at the local level. The workshop gives concrete recommendations on conducting an in-depth analysis to understand and monitor the phenomena and dynamics of polarisation through a local polarisation audit.</p> <p>Furthermore, cities will introduce concrete strategies to prevent or mitigate polarisation through activities that foster social cohesion and citizen participation. 10	<p>Good Practice in Deradicalization Interventions and in Policy Making: With a Focus on Inter-Agency Cooperation and Confidentiality</p>	<p>On four different European sites, the EXIT Europe project has begun building local exit programmes. In doing so, we put to the test the principles of good practice both in exit/rehabilitation work and in policy-making/programme design. Drawing on the RAN Derad Declaration, the programme confirmed the established principles as trust-building, relationship work, voluntary consent/ intrinsic motivation.</p> <p>The principles of triangular work and open process, focusing on narrative-biographical communication and emotional intelligence were also evident. It proved most important to provide a “safe space” with uncompromised confidentiality and the protection of personal data for the client – which only good practice in policy making can provide (as well as mustering an unpolitical, all-partisan support and providing a cross-extremisms approach which is non-stigmatising and non-polarising).</p> <p>Most remarkably, in EXIT Europe, international NGOs successfully cooperated with a member state’s security agency.
